

## ATF 2026 Season Member Sign Up and Waiver Form

I have read and understand and agree to the ATF rules for trail tournaments as posted on the ATF online registration page at [www.americateamfishing.com](http://www.americateamfishing.com). I will obey all trail rules, state, and federal rules that apply. I understand and acknowledge that competitive fishing is a dangerous sport and participation in ATF trail events and related activities involve inherent and significant risks, including, but not limited to injuries from hooks, lures, knives, and other fishing equipment and paraphernalia; collisions on the water or at launch/landing sites; slips, trips, and falls on docks, ramps, vessels, or shorelines; adverse weather and water conditions; vessel wake and wave impact; equipment malfunction; wildlife encounters; and drowning. I understand these risks may result in serious injury, illness, permanent disability, property damage, or death to me or others, including spectators. I further understand that risks may be unforeseen or not specifically identified. By signing below, I certify that I have read and understood the above risks and the ATF rules referenced in this form, and I knowingly, voluntarily, and freely assume all risks of injury, death, and property damage arising from or related to my participation in ATF trail events, tournaments, and activities, whether identified or not identified herein, and whether arising from my own actions, the actions of others, or conditions of the event premises or waterways.

I hereby release, discharge, and hold harmless and indemnify, the ATF trail, it's Officers, its partners, tournament workers and volunteers, host sponsors, tournament officials, and all other persons or entities associated with this trail's events and tournaments from all liability, claims, or rights of action which are related to, arise out of or are in any way connected with my participation in this trail or trail sponsored or related tournaments, including specifically but not limited to the negligent acts or omissions of the ATF trail, it's Officers, its partners, tournament workers and volunteers, host sponsors, and tournament officials, and all other persons or entities associated with this trail's events and tournaments, for any and all injury, death, illness or disease, and other damage or loss to property suffered by myself or others. I give my permission to the trail to use any photo or video that may include my image to advertise the trail and any trail event on social media or trail website. In signing this document, I acknowledge and agree that if anyone is hurt, or property damaged while I am engaged in any ATF trail event or tournament, I have no right to make a claim or file a lawsuit against the ATF trail, it's Officers, its partners, tournament workers and volunteers, host sponsors, tournament officials, and all other persons or entities associated with this trail's events and tournaments.

If any part of this Agreement is found unenforceable, the remainder of the Agreement remains in full effect. This Agreement will be governed by the laws of the State of Georgia without regard to conflicts of laws principles. Any action or proceeding seeking to enforce any provision of, or based on any right arising out of, this Agreement may be brought against either of the parties of the courts of the State of Georgia, County of Haralson, or, if it has or can acquire jurisdiction, in the United States District Court for the Northern District of Georgia (Newnan Division), and each of the Parties consent to the jurisdiction of such courts (and of the appropriate appellate courts) in any such action or proceeding and waives any objection to venue laid therein.
